

## WAIVER AND RELEASE FROM LIABILITY

I, \_\_\_\_\_, HEREBY WAIVE AND RELEASE, hold harmless and forever discharge the organizers and venue owners of the Gravity Games Asia: Highlands Chase 2010 (the "GG Highlands Chase 2010") and their sponsors, agents, employees, heirs, successors, and participants (the "released parties"), from any and all claims, demands, debts, lawsuits, damages, and liabilities, of every kind and nature, including liabilities from injury to person, property, employees and/or reputation that I may receive from or in any way related to my participation in the GG Highlands Chase 2010, or caused by any construction or condition of the course over which the GG Highlands Chase 2010 are held.

I acknowledge, agree, and represent that I understand that the activities in which I will participate, are inherently dangerous and may cause serious or grievous injuries, including bodily injury, damage to personal property and/or death. I understand the nature of longboard downhill racing and/or freestyle riding and that I am qualified, in good health, and in proper physical condition to participate in such activities.

On behalf of myself, my heirs, assigns, administrators, executors and next of kin, I waive all claims for damages, injuries and death sustained to me or my property that I may have against the released parties.

I understand that the released parties have no obligation to insure participants of the GG Highlands Chase 2010 and I agree to take **full responsibility** for any damage or injury to myself or my property that I may sustain as a result of my participation. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the activity.

I allow the released parties the right to use my name, pictures, videos, and biographical data (collectively "Info") in connection with my participation in the GG Highlands Chase 2010 for promotional or archival purposes without compensation or other consideration. I discharge the released parties from any claims arising out of or in connection with the making or use of the Info.

I understand that my participation in GG Highlands Chase 2010 is solely upon the discretion of the organizers and that they reserve the right to refuse participation to this as well as future events in the case that participants conduct themselves in a manner that may could put other participants in danger or in any way that may be detrimental to the successful conclusion of the event or future events. Furthermore, my participation in the event is subject to meeting all technical inspection requirements and by my participation I agree to be bound by the rules governing the event.

The provision of this WAIVER AND RELEASE will continue in full force and effect even after the termination of the GG Highlands Chase 2010.

I have read, understood, and fully agreed to the terms of this WAIVER AND RELEASE. I understand and confirm that by signing this WAIVER AND RELEASE I have given up considerable future legal rights. I have signed this Agreement freely, voluntarily, under no duress or threat of duress, without inducement, promise or guarantee being communicated to me. My signature is proof of my intention to execute a complete and unconditional WAIVER AND RELEASE of all liability to the full extent of the law.
